Neighborhood Pond

2018 HOA Assessments

The 2018 HOA assessments have been mailed. Payments are due February 1st. Having to send reminder letters costs time and money that is better spent on maintaining and improving your neighborhood. This also allows us to budget early for improvements. We want to enhance our entrance landscaping this year, which is a benefit to all homeowners, but need to know in March that we have the funds to do this. Remember, your HOA assessment has not increased but our costs for utilities, mowing and landscaping has, so it is imperative that EVERYONE pay on time.

Article 4e of the Kingswood Homeowners Association, Inc. Bylaws, states; If the assessments are not paid when due, then such past due assessments shall bear interest at the rate of twelve percent (12%) per annum and shall become a continuing lien on the property subordinate to the lien of any mortgage and such assessments shall be and shall remain the personal obligation of the lot owner and shall be enforceable against him/her as provided in the Declaration. Attorney fees and court costs will also be added to the lien.
