**Annual HOA Dues:** Yes, it's that time of year again. Your invoice for our annual HOA dues will be mailed prior January 1. They are due by January 31. Thank you in advance for your prompt reply. Dues received after Jan 31 are assessed a \$5 late fee. If you will be paying late, please include the late fee with the payment. Also, please be aware that properties with any prior year's unpaid dues are placed in lien with Bullitt County. The lien includes 12 percent per annum interest for unpaid dues, plus filing fees and court costs, to be collected at the time of sale.
